# 1. IN-PERSON | \$199 Registration Fee

# FREQUENTLY ASKED QUESTIONS

## How do I purchase on-demand?

You can add your on-demand package at the time of registration, located on the same page as the additional workshops. You can also purchase an on-demand package after the meeting.

#### When can I access the on-demand recordings?

The on-demand recordings will be available a week after the meeting. The included recordings and content will be sent via a link to everyone who purchased the package.

## What's included in on-demand?

All on-demand recordings will include a view of the presenter's slides along with audio from the session. On the sessions that are "Included (with speaker video)", video capture of the speaker will also be available to watch in the recording.

## How do I purchase Livestream?

Starting on July 29, a Livestream registration option will be available on the Exhibitor Meeting registration site. Simply add this option to your cart to complete your registration. Purchasing the Livestream will not give you access to the recordings after the meeting.

## When can I access the Livestream?

Everyone who registers for Livestream will receive a link prior to the event, granting them access to an online meeting room. All designated content (see chart above) will be presented on Livestream. Viewers will be able to ask questions and engage with the speakers on stage.

## Can I cancel my registration?

You may cancel your registration before July 19, 2025 for a refund, less a \$10 cancellation fee. If you cancel after July 19, 2025 then no refund will be issued.
